General Information:

Dogz Canine Sports Centre would like to invite you to their Obedience Fun Matches, to be held at their facility in Nepean, Ontario. It's a great chance to prepare for trials and practice in a simulated environment. The event will be run according to CKC rules, and will be informally judged.

Classes: All classes up to and including Utility.

Entries: Can be made in advance by mail or email, or you can register the day of the event as long as the maximum number of runs has not been reached.

Facilities: The Fun Matches will be held outdoors in a fully fenced grass ring (no chance of escape!). Washrooms are available, parking is close to the ring, there's plenty of room for tents/crates around the ring, and spectators are more than welcome. The event will still run in the event of rain, but will be postponed if the weather is severe. Cancellations will be posted on the Dogz Facebook page.

Directions:

Dogz ~ 3859 Carling Avenue, Nepean

- From the 417 take the March/Eagleson exit and go north (right if you're travelling west, left if you're travelling east). Turn right at the lights at Herzberg Road – cross the railway tracks – turn right at the lights at Carling Avenue. Dogz is the first driveway on the left (look for the sign)
- From Carling, go west past Moodie Drive – under the train bridge – Dogz is the last driveway on the right before you get to the lights at Herzberg Road (look for the sign).

Schedule of Events:

Any changes to the event/schedule will be posted on the Dogz Facebook page prior to the event.

Notice to Competitors:

As the purpose of our Fun Matches is to encourage enthusiastic runs in a trial environment, toys, treats and corrections are allowed in the ring while you're running your dog. There will be a 5 minute maximum applied to all runs to help ensure that the fun match will not be excessively long.

There shall be no refunds for no-shows, or if a dog and/or handler is dismissed from competition - regardless of the reason for such dismissal - or in the event of inclement weather. Cancellations must be received the Sunday prior to the match.

NOTE: For events held outdoors at Dogz, there's acres of mowed trails to walk your dog on leash during the match, as well as a fenced one acre Playground for off leash use. We do ask that you poop-n-scoop and keep your dog on a leash at all times when outside of the training rings as there are horses and other wildlife on the property.
