## General Information:

Dogz Canine Sports Centre would like to invite you to their AAC (Agility Association of Canada) Sanctioned Agility Trial.

Title Trial: Dogs will be divided into six height groups. Regular, Special and Veterans classes will be offered.

Obstacles: A-Frame, Dog Walk, See-Saw, Weaves Poles, Table, Flexible Tunnels, Breakaway Tire Jump, Ascending Spread Jump, Double Bar Jump, Single Bar Jumps. **Contacts are rubberized!**

Facilities: The trial will be held outdoors in 2 fully fenced grass rings – Ring 1 for Starters and Ring 3 for Advanced. Washrooms are available as well as parking near the ring. There's plenty of room for tents and crates, and spectators are more than welcome. The event will still run in the event of rain.

Food and beverages will be available for the duration of the trial., including a BBQ catered by Kim Steele at lunchtime!

There is a fenced off-leash play area and acres of land to walk your dog on a leash during the trial. We do ask that you poop-n-scoop and keep your dog on a leash or crated when outside of the agility rings.

## Directions:

Dogz ~ 3859 Carling Avenue ~ Nepean, Ontario

- From the 417 take the March/Eagleson exit and go north (right if you're travelling west, left if you're travelling east). Turn right at the lights at Herzberg Road – cross the railway tracks – turn right at the lights at Carling Avenue. Dogz is the first driveway on the left.
- From Carling, go west past Moodie Drive – under the train bridge – Dogz is the last driveway on the right before you get to the lights at Herzberg Road.

**The sequence of classes for both Starters & Advanced will be:**

**Standard 1, Standard 2, Gamblers 1, Gamblers 2, Snooker 1, Snooker 2, Jumpers 1, Jumpers 2**

All classes for both levels will run in parallel (ie/ ST1 and AD1 will start at the same time, etc)  
There will be no familiarization, but two jumps will be set up in by each ring for the duration of the trial.

## Notice to Competitors:

All dogs must have an AAC ID number to compete, and the ID number must be verified upon check in.

There shall be no refunds for entries withdrawn after the closing date, or in the event that a dog and/or handler are dismissed from the trial, regardless of the reason, or in the event of inclement weather. Refunds will be issued for dogs that come into season or are injured, providing a veterinarians certificate is received by the Trial Secretary within 48 hours of the trial date.

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my “**Related Parties**”), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the “**Personnel**”) for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers’ fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
  - (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
  - (b) aggressive behaviour by the Dog or any other dog under my control.

I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the “**Rules**”). I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.

I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.
