<u>Please register for these Fun Matches online, by email or mail</u> - Entries close at 5:00 pm the Thursday prior to each event. Space permitting, entries may be accepted by email before noon the Saturday before the fun match. You only need to bring the form to your first event — we'll check off the other dates as needed.

#### **General Information:**

Dogz Canine Sports Centre would like to invite you to their 2023 Agility Fun Match series. Each fun match is an individual event, so you can enter them one at a time or any number of them in one shot! We will have 2 judges at each match, so we'll be running both rings at the same time and the matches will be finished in the early afternoon. Also, someone will be available to measure your dog during registration/lunch break if you'd like a chance to practice this.

Classes: Starters, Advanced and Masters level courses will be offered at all jump heights for 1 Standard and 1 Games

course, and you will be able to run each course twice. Courses are nested (so the A Frame will be set at 5', and

there will be no spread jumps), and classes will be run by jump height regardless of level.

Obstacles: A-Frame, Dog Walk, See-Saw, Weaves Poles, Table, Flexible Tunnel, Breakaway Tire Jump, Single Bar Jumps.

All contacts are rubberized.

Facilities: Outdoors @ Dogz: The event will be held in 2 fully fenced grass rings (no chance of escape!). Washrooms are

available as well as parking near the ring. There's plenty of room for tents and crates, and spectators are more

than welcome. The event will still run in the event of rain.

#### **Directions:**

Dogz ~ 3859 Carling Avenue ~ Nepean

- From the 417 take the March/Eagleson exit and go north (right if you're travelling west, left if you're travelling east). Turn right at the lights at Herzberg Road cross the railway tracks turn right at the lights at Carling Avenue. Dogz is the first driveway on the left.
- <u>From Carling</u>, go west past Moodie Drive under the train bridge Dogz is the last driveway on the right before you get to the lights at Herzberg Road.

PARKING will be located by the agility rings.

There will be no familiarization but two jumps will be set up in a practice area by each ring. You have 2 minutes in the ring for each of your 4 runs, and they can be timed and informally judged, in case you're interested in knowing how well you did!

#### **Notice to Competitors:**

This Fun Match will be run in accordance with AAC rules and regulations, and you'll get to do a walkthrough of the course prior to running it. The purpose of our Fun Matches is to encourage enthusiastic runs in a trial environment - toys/treats and targets are allowed in the ring while you are running your dog, and you are permitted to run your dog at jump heights lower than what they normally would jump in a sanctioned trial. Competitors will have the opportunity to run each course twice (or do another level course for your second run), with the second run offered after everyone has completed their first round. Runs will be timed, and the judge is there not only to monitor your run, but to offer feedback on how you can improve your run if you want it - they'll even help to get you back on course should you get lost  $\odot$ 

NOTE: For events held outdoors at Dogz, there's a fenced off-leash play area and acres of land to walk your dog on leash during the match. We do ask that you poop-n-scoop and keep your dog on a leash when outside of the agility rings as there is livestock on the property...
